



INSTRUCTION FOR AUTHORS

I General information

All abstracts and papers undergo a review process. Official languages of the conference are Bosnian/Croatian/Serbian and English. The submissions should be written in Bosnian/ Croatian/ Serbian or English language. The authors are responsible for grammar and spelling mistakes.

Submitted papers should include title and abstract with approximately 250 words and up to 4-5 key words. Abstract should include subject and the aim of the research, results and their implications.

The papers should be submitted in electronic form, as attachment and open access document (MS Word format) to e-mail address: diec@ipi-akademija.ba.

Content of any submissions should be original and should not have been published before in their current or substantially similar form. Furthermore, they must not be submitted for consideration in any other conferences or journals.

II Important dates / deadlines

- 31 January 2018 Abstract submission deadline
- 15 February 2018 Notification of abstract acceptance
- 31 March 2018 Full paper submission deadline
- 20 April 2018 Notification of paper acceptance
- 30 April 2018 Registration deadline

III Instructions for writing papers / paper requirements

Paper should be written in Bosnian/Croatian/ Serbian and English language. Submitted papers should be between 9-15 pages including abstract, literature review, references, tables and graphs.

In the left corner of the first page there should be full author's name and title (Times New Roman, 12pt.). Footnote should include basic information about the author (title, name of the author's institution and e-mail address).

Three lines under there should be placed the title of the paper (Bold, Times New Roman, 14pt).

Paper should be written in Microsoft Word for Windows and with the following forms:

- A4 format;
- Margin 2.0 cm;
- Letters Times New Roman, 12pt, single spacing;
- Tables, pictures i footnotes 10pt.

Papers will be published in Conference Proceedings (with ISSN number).

IV References and citing

- When citing in the text, use author's name and put the year of publication in brackets
- Number tables consecutively in accordance with their appearance in the text and place any table notes/names below the table body. References should be placed under the tables.
